NEW BUSINESS:

- 1. Clerks Report- Motion to accept the Clerk's Report: Bob/Terry (3/0)
- 2. Treasurers Report Motion to accept the Treasurer's Report: Terry/Bob (3/0)
- 3. Strategic Planning RFQ 12 Bids were received with a range between \$43,000.00 and \$190,000.00, after reviewing said bids and references, the strategic planning committee recommends Mejorando Group with their bid of \$43,200.00 plus mileage. Motion to accept Mejorando Group as the Strategic Planning RFQ: Bob/Terry (3/0)
- 4. Emergency Use of TIF Funds for Trail Repair Discussions were had to use emergency funds from TIF to repair trails for the upcoming snowmobiling/recreation season. Concerns were made that without the use of these trails there will be a loss of revenues for Franklin County and the UT. Motion was made to approve up to \$1000,00.00 in emergency trail repairs along with access to gravel and culverts that are not committed, with the understanding that they must submit an application for TIF funding: Lance/Terry (3/0)
- **5.** Langtown Plowing Discussion was had regarding the Nash Stream Bridge being out and the contractor contracted to plow the roads residing on the other side of the bridge. A plan was made for the contractor to stage a truck on the other side of the bridge allowing him access via: the temporary walking bridge to the staged truck to plow the roads.
- **6. EMA December Storm Update** As of December 29, 2023, Franklin County has incurred \$3,000,000.00 in damages from the storm and the UT had incurred \$48,135.00 in storm damages. A meeting is to be held with FEMA at some point next week.

OLD BUSINESS:

1. Orberton Stream Bridge Update — New bridge has been built. Just to clarify, the weight limit has not been lifted. The State of Maine must lift the weight limit. Therefore, the 3-ton weight limit is still imposed until further notice. Motion was made to have RFP, Engineering Firm to review the bridge and develop plan for bridge repair: Bob/Terry (3/0)
