- **3. FY2025** Overall Budget Summary (Amy Bernard, County Administrator) The County Administrator discussed the overall expenses and revenues the county is facing for FY2026. She highlighted increases/decreases within each department. She indicated that expenses are up 9.8%, mostly due to contractual cost increases for services and staff increases. Revenues are down approximately 33% due to zero use of undesignated fund balance to offset the taxes.
- **4. Review FY2026 Budget Proposals** The Budget Advisory Committee reviewed and discussed each department's FY2026 Budget. Questions were asked regarding employee compensation, incentive pay, document preservation (Commissioners office), Sheriff vehicles, Health Insurance,

Retirement, Dues and Subscriptions (Probate), Administrative Assistants employee wages (wages, health insurance and retirement are allocation: 1/3, Commissioners Office, 1/3 Treasurer's Department and 1/3 Unorganized Territories). Inquiries were made regarding the Part-time employee's job description for the Commissioner's office.
