Franklin County Commissioner's Meeting June 17, 2025

- 1. Plog Property Site Review at 2571 Rangeley Road, Madrid Township The Commissioners visited the property located at 2571 Rangeley Road, Madrid Township along with Adam Catrell from the USDA, Natural Resources Conservation Service to Drogram to assist with the stabilization of the Emergency Watershed Protection Plog's property. Mr. Plog is at risk of losing his well and home due to the erosion of the riverbank if efforts to stabilize the riverbank are not made. The estimated cost for the project is \$200,070. Motion to go out to bid for the Plog Property Emergency include if bids come in too high, the County will reach out to the USDA, Natural Resources Conservation Service to discuss other options (4/0).
- 2. Cochran Property Site Review at 2709 Rangeley Road, Madrid Township The Commissioners visited the property located at 2709 Rangeley Road, Madrid Township along with Adam Catrell from the USDA, Natural Resources Conservation Service to along the Cochran's property. The Cochran's are at risk of losing their home due to the erosion of the riverbank. The Cochran's are in the process of repairing the foundation that estimates and discussed different project options. Commissioner Carlton brought up the concern was the runoff from the road. No Action Taken.

Emergency Operations Center Insurance MCCA Risk Pool requested approval of the Coverage Limits \$4,250,000 EOC Building, \$750,000 County-owned contents/equipment and \$20,000 PITO (detached exterior property, such as garages, signs, fences, benches, utility poles in parking lots, etc.) at this new location. Contents/equipment to include items that are not permanently attached to the building, such as computers, telephones, appliances, furniture, etc. Motion to approve the coverage limits provided by MCCA-Risk Pool: Tom Saviello/Tom Skolfield (5/0).
- 12. TIF Applications The Commissioner's reviewed and approved the following TIF Applications:
 - A. Madrid Historical Society Looking to construct a pavilion. Motion to approve TIF Funding in the amount of \$50,000: Fen Fowler/Tom Saviello (5/0).
 - B. United Methodist Economic Ministry Looking to establish a firewood production line to include a processor and storage to provide wood to families in need, along with collaborating with Western Maine Community Action to provide weatherization to homes that the UMEC provides wood to. Motion to approve funding in the amount of \$50,000, with the caveat that if a more expensive wood processor is necessary that they come back to request additional funding: Tom Saviello/Tom Skolfield (5/0).
 - C. Greater Franklin Economic and Community Development Provide marketing, infrastructure, employment, training, workforce housing, child and family services, and workforce development to community members. Motion to approve funding in the amount of \$141,000: Fen Fowler/Tom Skolfield (5/0).

- D. Beth Brunswick Memorial Fund for Children Rangeley Childcare Center -Looking to construct and operate a childcare center and secure funding to be able to provide scholarships to UT families to reduce the cost of childcare at the facility. Motion to approve funding in the amount of \$70,000: Tom Skolfield/Tom Saviello, friendly amendment indicating that a process must be provided on how and when funds are drawn down. (5/0).
- E. Narrow Guage Riders ATV Club Looking to build a bridge over Crossman Stream that was damaged during the flooding in 2023. This bridge connects Madrid and Byron. Motion to approve funding in the amount of \$35,000: Fen Fowler/Tom Saviello. Items of concern are: confirmation of landowner permission, acknowledgment that they have been awarded the State grant for ATVs, signing the Application, LUPC compliance, bridge access open to everyone, the deed needs to specifically state that access would be continuously provided. Rescind Motion Fen Fowler/Tom Saviello. Motion to Table: Tom Saviello/Tom Skolfield (5/0).
- 13. Reserve Account In April, the Commissioners consolidated reserve funds into the Roads and Bridges Reserve Account. We have begun the process of replacing the two bridges in the UT and need permission to pay the invoices that are coming in out of the Reserve Fund.
