1. Introduction and Purpose

Franklin County is seeking qualified and licensed electrical contractors to provide on-call and project-based electrical services at various County-owned and -operated buildings. The goal is to ensure safe, timely, and code-compliant installation, repair, and maintenance of electrical systems in support of County operations.

2. Scope of Work

The selected contractor(s) shall perform a range of electrical services including, but not limited to:

- Diagnosis and repair of electrical systems and components.
- Installation and maintenance of wiring, outlets, switches, panels, and lighting.
- Emergency response to power outages or hazardous conditions.
- Generator maintenance and hook-up services.
- Electrical work related to HVAC and building automation systems.
- Upgrades to meet NEC and ADA compliance.
- Energy efficiency improvements (e.g., LED conversions).
- Preventative maintenance and inspections.
- Coordination with utility providers and inspectors as needed.

Services may be scheduled during business hours or required after-hours for emergencies.

3. Site Locations

Work may be required at any of the following County buildings (not exhaustive):

- Franklin County Courthouse
- Franklin County Jail
- Franklin County Emergency Operations Center
- Franklin County Dispatch Center

4. Contractor Requirements

- Valid electrical contractor license in the State of Maine.
- Minimum of 5 years of commercial/public-sector experience.
- Proof of insurance meeting County minimums (general liability, workers' comp, auto).
- Ability to respond to emergency requests within 2 hours.
- OSHA-certified staff and adherence to all safety protocols.
- Familiarity with NEC, NFPA, ADA, and applicable state/local electrical codes.

5. Proposal Requirements

Interested contractors must submit the following:

- Company overview and contact information.
- Qualifications and experience of key personnel.
- List of at least three (3) references with similar contracts.
- Hourly rate schedule (regular hours, overtime, holidays).
- Mark-up rate for materials and parts.
- Proof of required licenses and insurance.
- Sample project documentation (work order, report, or invoice).
- Any subcontractor information (if applicable).

6. Contract Terms

- The County intends to award a 1-year contract, with two optional 1-year renewals.
- No minimum amount of work is guaranteed.
- Multiple contractors may be selected.
- Work shall be scheduled by County staff via work orders.
